### LICENSE FEE FOR EXHIBITION PREMISES

1. All national and Regional Distributors' licenses are for a period of 5 years in the first instance and renewable yearly.
2. All District/ Community licenses are for a period of 3 years in the first instance of license and renewable yearly.
3. Exhibitor and Exhibition premises license are two separate licenses.

### REGISTRATION AND LICENSING PROCESS / PROCEDURE

- a) Collection/Submission of forms to the Commission
- b) Documentation Process by the Commission.
- c) Review and Assessment of the submission documentation of an application
- d) Commission publishes Successful applicants.
- e) Payments of license fees by successful applicants
- f) Issuance of licenses.
