The Uganda Communications Commission (UCC) has allocated funds under the Uganda Communications Commission Universal Service and Access Fund (UCUSAF) to be used to enhance the access to information and communications services by persons with disabilities; through the use of information and communications technology (ICT)
2. The Uganda Communications Commission now invites sealed bids from eligible bidders for supply, delivery and installation of ICT and Assistive Technology Equipment for People with Disabilities in four regional resource centres.
3. Bidding will be conducted in accordance with the Open Domestic Bidding a procedure contained in the Government of Uganda's Public Procurement and Disposal of Public Assets Act, 2003, and is open to all bidders.
