ABRIDGED BID NOTICE UNDER OPEN BIDDING.

The deadline for bid submission shall be at 10:00 AM on 29th September 2025.

BID NOTICE UNDER OPEN BIDDING.

Bids must be delivered to the physical address below at 8(c) **at or before 29th September 2025 at 10.00 am**. Bids shall be accompanied by a bid security /bid Bond of UGX. **10,000,000/=**. Late bids shall be rejected. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below at 8(d) at **10.15 am on 29th September 2025**.

BID DATA SHEET: ITB 10 (j).

ESHS Code of Conduct for contractors' personnel

The bidder shall submit the Code of Conduct that will apply to the contractor's employees and subcontractors as required. The Code of Conduct shall ensure compliance with the ESHS provisions of the contract, including those as may be more fully described in the Statement of Requirements in Section 6.

In addition, the bidder shall submit an outline of how this Code of Conduct will be implemented. This will include how it will be introduced into conditions of employment/engagement, what training will be provided, how it will be monitored, and how the contractor proposes to deal with any breaches.

ESHS Management Strategies and Implementation Plan

The bidder shall submit a comprehensive and concise Environmental, Social, Health and Safety Management Strategies and Implementation Plans (ESHS-MSIP) as required. These strategies and plans shall describe in detail the actions, materials, equipment, management processes etc. that will be implemented by the contractor and its subcontractors.

In developing these strategies and plans, the bidder shall have regard to the ESHS provisions of the contract, including those as may be more fully described in the Statement of Requirements in Section 6.
