- 1. The Uganda Communications Commission (UCC), Under the Uganda Communications Commission Universal Service Access Fund, has allocated funds for the procurement of ICT Textbooks.
- 2. The Uganda Communications Commission invites sealed bids from eligible bidders for the Supply, Delivery, and distribution of ICT Textbooks to Various Secondary Schools in Uganda.
- 3. Bidding will be conducted in accordance with the Open Domestic Bidding procedure contained in the Government of Uganda's Public Procurement and Disposal of Public Assets Act, 2003, as amended, and is open to all bidders.
